Subject: Engagement of Conductor (Dependant of the deceased employees) on short-term contract for a duration of one year at a time (extendable on the basis of performance of the candidate/requirement of the Corporation).

This Corporation is in process of engaging Conductors on short-term contract for a period of one year, likely to be extended taking into consideration the performance of the candidates as well as requirement of the Corporation.


The contractual conductors will be paid rates of minimum wages as per the rates prescribed by the Govt. of NCT Delhi from time to time plus a maximum incentive of Rs. 1500/- per month and yearly bonus (subject to fulfilling the applied conditions) etc. Apart from the wages, the Corporation will pay the statutory contributions towards Management's share on account of ESI & PF at the prescribed rates, i.e., 3.25% and 12% respectively applicable from time to time.

In case you are interested to work as Conductor on contract basis and having educational qualification as Matriculation, maximum age limit of 35 years (relaxation in case of PHP 10 years, SC/ST 05 years & OBC 03 years) and Conductors' valid license issued by STA, Delhi. Further as per Resolution No.28/2019 dated 14.06.2019, Seven years one time age relaxation has been granted by the DTC Board. You may appear before the Selection Committee for interview along with all original testimonials viz. (i) Proof of age (ii) Educational qualifications certificate/caste certificate (iii) Conductor valid licence issued by STA, Delhi and photostat copy of each document (duly attested) (iv) First-aid certificate, failing which conditions for the post of Cont. Conductor will not be considered thereof & also three recent passport size (colored) photographs and two 4x6 photographs at the office of Manager(Personnel.), Delhi Transport Corporation, Indraprastha Estate, New Delhi-110002 on 17-08-2021 at 10.00 hours. The candidate should not have been convicted/pending criminal case(s) in any Court of Law.

The selected candidates will, however, be engaged on short-term contract subject to their medical fitness to be adjudged by the DTC Medical Board & Training to be imparted by DTC Training School. The appointment on short-term contract basis will not entitle the candidate to have any claim of regular appointment or absorption in DTC on regular basis and their services could be terminated for violation of contract agreement as per rules.

At any point of time if it comes to notice that earlier the dependent of deceased employee has got benefit of compassionate appointment/any appointment in DTC, he will not be entertained for the purpose and necessary action will be taken him including termination of his claim for appointment on compassionate ground.

No TA/DA will be paid for the purpose of scrutiny of documents.
